• The non-exclusive mandate is given for a defined limited period of time, the owner will inform HORIZON Properties if a transaction is made with another agency for his unit.

• Charges (electricity, water and internet) are to be paid directly by the tenant

• The fixed fee is calculated on a pro rata basis in the case of a rental contract of less than 1 (one) year

• An agent's commission equivalent to 1 month's rent + VAT is payable to HORIZON in the event of a transaction carried out by HORIZON Properties
