## A/ EXCLUSIVE MANDATE

#### **OUR SCOPE OF WORK**

- Production of audiovisual material allowing the valorisation and distribution of the distribution of the property (at least semi-professional photo shooting).
- Sharing the mandate with a selection of specific partner agencies and regular commercial animation
- Management of the keys, organisation and presence during all the visits carried out with our partner agents
- Monthly review of activities and marketing actions carried out
- Management of the sales process with the buyer and the third parties involved: notary and EDB in particular
- Supervision and implementation of the procedure for delivering the keys to the buyer

## >> TRANSACTION FEE (in case of transaction):

2% of the sale price + VAT

#### **TERMS & CONDITIONS**

- The exclusive mandate is given for a limited period of time and is then transformed into a simple non-exclusive mandate.
- The end of HORIZON Properties' mission is recorded at the signing of the sales contract at the notary's office
- An transaction fee equivalent to 2% of the value of the transaction + VAT is due to HORIZON in the event of a transaction, whatever its origin
- An agent's commission equivalent to 1 month's rent + VAT is due to HORIZON in the event of a transaction, whatever its origin

# **B/NON-EXCLUSIVE MANDATE**

- Organisation of the visits with our partner agents
- Management of the sales process with the buyer and the third parties involved: notary and EDB in particular

# >> TRANSACTION FEE (in case of transaction) :

2% of the sale price + VAT

- The non-exclusive mandate is given for a defined limited period of time, the owner will inform HORIZON Properties if a transaction is made with another agency for his unit.
- The end of HORIZON Properties' mission is recorded at the signing of the sales contract at the notary's office
- An transaction fee equivalent to 2% of the value of the transaction + VAT is due to HORIZON in the event of a transaction, whatever its origin
